

Under Armour Football Combine Clinic at the Competition Official Rules and Conditions

1. NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE CHANCES OF WINNING.

2. SPONSORS. The Under Armour Combine Clinic Competition (the "Contest") is sponsored by Under Armour, Inc., 1020 Hull Street, Baltimore, MD 21230 ("Under Armour") (the "Sponsor").

3. ELIGIBILITY. Open only to legal residents of the state of Georgia who are between 14 and 17 years of age and have obtained their parent's or legal guardian's permission to enter. Void where prohibited by law. Employees of the Sponsor, Hibbett Sporting Goods, Inc. The combine clinic will be held at the Georgia Dome, Atlanta Georgia on April 26, 2009, 8:00 a.m. – 11:00 a.m. All expenses and costs, including but not limited to, transportation, meals, lodging, or other expenses are the responsibility solely of each Contestant. Sponsor reserves the right, in its sole discretion, to accept more than 120 registrations.

5. COMPETITION. Each Contestant will be required to perform football combine style drills. The five (5) Contestants with the highest combined drill scores will be selected as the winners. All decisions regarding the winners are final.

6. PRIZES. Each winner will receive credentials to participate in the Under Armour Football Combine at the Georgia Dome, Atlanta Georgia, April 26, 2009, 1:00 p.m. – 6:00 p.m. and will receive the official gear of the Under Armour Combine (approximate retail value: \$70). Any difference between the stated value and actual value of any prize will not be awarded. Insurance, gratuities and other expenses not listed are the responsibility of the winners. Prizes are non-transferable and no substitution or cash redemption will be made, except in case of the unavailability of the prize or a prize component, the Sponsor reserves the right to award a prize of equal or greater value.
